Aditya Birla Private Equity, part of the billionaire Kumar Mangalam Birla-led diversified Aditya Birla Group, started investing nine years ago and built a portfolio of a dozen-and-a-half companies. The PE firm launched its first fund with a corpus of Rs 881 crore in 2009. In 2011, it began investing out of its second fund that closed at Rs 330 crore. It is on the road now to raise its third fund. 


